Community Center Re-Build Update GIVE Where You LIVE!

Thank you to everyone who has donated to Community Center re-build project. Much has been done to create a financial condition to make this dream possible. Round 2 of fundraising began in late-November 2018 (following the Fire Board's decision to enter into a lease agreement for space in the new Community Center). Since then, over 100 families have contributed nearly \$525,000 (cash and pledges). We are so grateful.

In order to begin construction, we need to have at least \$800,000 raised through donations and

pledges. That means raising an additional \$275,000, and then we can break ground! Please join the community wide effort to complete this goal no later than July 5th. You may be hearing directly from one of our fundraising team who will gently encourage your participation and answer your questions. We are fortunate to have funds from prior gifts, our commercial loan, and private financing from members of the community that allow an extended giving plan. Your pledge now, with cash gifts now or in installments by 6/30/19, 12/31/19, and up to 4/1/2020 will support the construction schedule. Donations are eligible to be tax deductible. Please check with your employer to find out if they have a "matching contribution program". Your pledge to Give Where You Live means we will have no regrets.

News & Notes from Supervisor Katie Rice

Climate Change Is a Local Issue

Climate change is a reality. Residents of Marin don't need to look far to see or feel its effects — from rising tides regularly overtopping the Mill Valley/Sausalito Bike path, flooding freeway onramps in southern Marin, or combined with rain events forcing the closure of 37 in northern Marin.

More frequent, intense and disastrous wildfires are engulfing wild lands and suburban communities in fires up and down the state. And these fires are posing a real public health threat beyond the immediate burn area as their smoke inundates communities far away. In the case of the Paradise/Butte County fire, for a period of roughly two weeks, the 7 million strong Bay Area experienced unprecedented air pollution impacting not only the most vulnerable (those with asthma, heart disease) but everyone else as well.

As your representative on the Board of Supervisors, as a member of the Bay Area Air Quality Management District, the Transportation Authority of Marin, The Marin Transit District to name a few, I'm involved daily in discussions, budgeting for programs, policy decisions, planning directly or indirectly related to climate change.

Last week I attended two conferences about local climate change. Each focused on how communities are adapting and responding to the more overt impacts of climate change affecting our lives and communities today, as well as planning for the increased impacts over the next several decades and beyond, which at this point given the green house gas emissions currently in atmosphere (let alone future emissions) are irreversible.

The first conference was on wildfire, specifically around California's vulnerability — which while always high, has been amplified exponentially with climate change. Weather patterns warmer overall year-round; longer, hotter, more frequent heat waves; increased frequency of the hot, dry and windy conditions (think Santa Ana winds in the south/ Diablo winds in the north) provide a key ingredient for major, and most destructive fire events.

The good news coming out of the Wildfire conference is that huge advances are being made in our ability to detect, prevent, contain and respond to fires. Proactive, ongoing vegetation management on public lands adjacent to urban areas will be key. The same for defensible space, home hardening, and emergency preparedness at the individual property and community level. The take away: Our fire risk won't go away but we can enhance our ability to prevent catastrophic fire with more focus, investment and collaboration on the part of all levels of government, industry (including utilities) and community. The second conference was focused on sea level rise here in Marin. Specifically, what residents should expect to see/experience here in the near and long term with regards to the impact of sea level rise on private and public property, transportation, public infrastructure, etc. Current forecasts predict 6-10 feet of sea level rise by the end of the century. The conference provided an overview of an array of projects being piloted here in Marin to protect, buffer, mitigate the impacts of near-term sea-level rise to buy time while we develop and find ways to finance the longer-term solutions needed for adaptations.

The take away: Sea level rise is a local, community wide issue. It will impact all residents whether or not they live near the bay or the coast — with some inconvenience in the near term, and with severe consequences for entire communities in the mid and long term.

Bottom line: Climate change is here, impacting us now, and with more severity in the future. And the message to public officials, community and industry leaders, residents, workforce, the entire public and private sector is the following: Meeting the challenge climate changes poses to our communities will require that we act at all levels of community, and that we participate, partner and collaborate in ways we have not before.

Next column: What can we do as individuals to further action and collaboration to mitigate the impacts of climate change? And what can we do as individuals, in one single action, to reduce our own individual carbon footprint by half?

SHHA Minutes February 7 & March 7, 2019

February 7, 2019

Call to Order 7:15 p.m.

Board members present: Spencer Adams, Pete Mayer, Jan Blackford, Shaun Westfall, Scott Hintergardt, Cathy Sarkisian, Jen Gauna, Ann Wagner. Others attending: Lorraine Ferrarese, Luke Argilla, Brendan Finn.

Open Time for Resident Comments:

Joe DiScala reported on the status of his effort to be allowed to split his lot. He will speak with Supervisor Rice and asks that the SHHA advocate for residents with Marin County at least to "break logjams." Dan Dumont was present also.

Jan: Board does not advocate a change in the ordinance; lean toward a variance. Will speak with County to understand the potential of precedence setting on the variance. Luke urged caution.

Adjourn 7:30 p.m. to conclude discussion with Sleepy Hollow Charitable Foundation board.

Reconvened SHHA Board 8:00 p.m.

Scott: Welcome new Board Member Ann Wagner. Scott is talking to several people about joining the Board, and to more as potential fundraisers. Will be getting list of block captains from SHFPD Director, to consider appropriate synergies and to support efforts to complete the block captain roster (Neighborhood Preparedness Coordinators). Jen suggested we revisit candidates who expressed interest in the board or other volunteer positions last fall.

Membership Update, Spencer

Just hit 50 people renewed or new in first week after email renewal reminders went out. Some members mistakenly received invoices, which will be voided. Complete membership packets will go out next week by U.S. Mail to all residents. Follow up reminders to members and information to lapsed members will be sent frequently. One unanticipated impact is being addressed: Occasionally a second member of the household establishes a new membership rather than renewing the existing one, in which case they have to be merged manually by an administrator. Pool renewal notices will go out to residents soon and to non residents around March 1.

San Domenico Traffic, Scott/Jan

Scott reported there have been 68 meetings about this over the past 2 years. Recently San Domenico clarified their preference for a revised plan that could be implemented for their 2019-2020 school year, rather than embarking on a trial or pilot. They presented us an updated outline of revisions to their Transportation Management Plan and have asked to come to the March board meeting to present the updates to the new, full board. They will prepare a narrative summary and graphics that Scott will send out ahead of time. Although they seem to prefer we work together for an amended plan, they will also raise with the SHHA Board the possibility of a pilot. SHHA Board decide whether we want to work toward an amended TMP or to focus on planning for a pilot.

Brendan Finn reminded the Board that in the past, Board members were assisted by a committee that was outside the Board, which helped with necessary research, made suggestions and recommendations to the Board, and seemed to help broaden the understanding of the community.

Jan reported that our SHHA standing committee has been formed after the resolution at the January 17 Annual Meeting, and will meet after the San Domenico presentation in March. Committee members are David Swaim, Dan Clark, Jan Blackford, with Scott Hintergardt as Chair.

A team of key fundraisers has planned this event as a last fling in the old clubhouse and rally to get excited about and support the new. Decorations and activities will encourage reliving old memories and building new ones. Tammy Parr is leading the planning with help from Holly Briese, Erin Badala, Pat Grubb, Carolyn Goodman, Darlene Hanley, and more volunteers. Tickets to be purchased in advance through the website. Open Time for Resident Comments: Garril Page spoke of her concern that the Board has responsibility to present an affordable project to the community for the new community center and her belief that the current project is not affordable and is not suitable for the community.

The entire meeting was devoted to hearing the presentation by San Domenico School for amendments to their Transportation Management Plan (TMP). Cecily Stock, Head of School and Sleepy Hollow resident, David Wise, Chief Financial Officer, Amy Skewes Cox, Chairman of the Board, and David Parisi, traffic consultant to the school, represented the school.

Cecily Stock presented the history of the school and its recent years as the school has gotten healthier, now reaching its maximum enrollment of 680, now co-ed and with a larger high school enrollment and boarding population, facing more competition to enroll students and engage parents, and is less and less able to conduct the activities they believe are necessary for the school to remain healthy within the current TMP.

Dave Parisi reported on some comparisons of the San Domenico TMP with traffic monitoring requirements and limits for other private schools, and a summary of data from traffic studies along Butterfield Road.

Cecily explained the current vehicle limitations, previewed increases in vehicle count for peak and off peak times that the school is seeking, and described reasons for those additional vehicle trips needed. The preview also included simplification of the monitoring and auditing, using a series of escalating fines if violations occur.

The school asked that we work with them to put an amended plan in place before the beginning of the next school year, and that if we cannot, that we instead work with them on a pilot plan that could be in place. They expressed a preference for a plan that would allow them to invest time and money in traf-

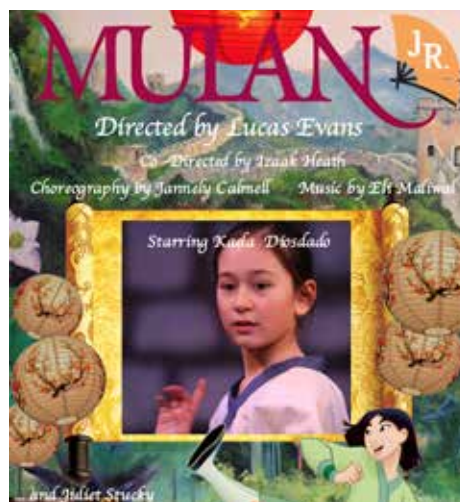

fic safety instead of monitoring and restricting necessary activities.

The SHHA board members were able to ask a number of questions about peak period traffic limits and impacts of increases, the potential for more or larger events on weekends or weekday evenings, enrollment expectations, changes in penalties, proposed vehicle counts compared to current actual counts, the feasibility for a closed campus at least at certain times, potential for adjusting bus schedules, and more. The school responded and asked that any plan or pilot consider how it might be possible to set a baseline for community use to reduce that uncertainty in future discussions.

Follow up includes: The SHHA standing committee will meet to review the requests and supporting materials and report to the SHHA Board at or before the April board meeting. Dialog with the school will continue toward a mutual goal of resolving the issues so that a joint proposal can be reviewed with the Sleepy Hollow Community on a path toward a plan that could be reviewed and approved by the County.

MMWD: What's Going On?

On Tuesday the water board voted to approve sending out a formal 218 Notice which begins the process to consider a water rate increase and rate restructure—you will be receiving that notice by mail in the near future. The notice will set out the details of the proposal. Be sure to look for that notice, if you don't like the rate proposal the 218 Notice gives you the chance to object.

The proposed changes are designed to achieve several positive results. Under the rate restructure your water bill will come in two components: your traditional every two month water bill will come by mail as usual, with increases kept within the Bay Area CIP range, and an a second component will be a capital maintenance fee collected twice a year with the property tax bill.

We are months away from any final decision on this proposal, and it is very likely to undergo changes throughout the process. There will be public outreach including several public workshops and several informational mailings. A forward plan will emerge, and, assuming the public has not rejected the plan, will be subject to final approval by the board of directors approximately sometime in May.

I was first elected to the water board in the late 1990s on a campaign against the district's history of rate insensitivity. I beat that drum loudly for several years, and voted against every rate increase for my first years on the board. Together with other like minded board members each year we spent hours going over the budget line by line, bringing it into reasonable parameters. The board at that time established a requirement that no new employee could be hired without specific board approval. That kind of cutting is no longer necessary or even a good idea. Today the water district is fiscally well managed, with 240 full-time employees, down from 265 at that earlier time, and, I hope you agree, the job gets done.

The major objective of the current proposal is to find a way to eliminate the district's outstanding bonds, and, even with the lower rates we pay, it will save the ratepayers \$190M over the life of the bonds, and still sustain the level of continuous infrastructure maintenance

and watershed management that is necessary to keep the district at top performance. This rate proposal is not driven by staffing needs, and pensions are well under control. It is driven by continuous maintenance of system and infrastructure needs which are required for a 100 plus year old system with 900 miles of pipe, 7 reservoirs and dams, 3 treatments plants and 22,000 acres of watershed, all of which require contentious care and maintenance.
