News & Notes from Supervisor Katie Rice

COVID and Cars and Community

COVID cases are down, vaccine supply and daily shots in arms are up. Things are heading in the right direction. While we're not out of the woods yet, it is feeling a bit more "normal" out there, including the downside of "normal" – traffic.

As a resident of Sleepy Hollow, living on Butterfield, I see, hear, and even feel changes in traffic volume and patterns. And while I'm happy about making progress on the pandemic front – kids going back to school, businesses and restaurants reopening – I haven't missed the traffic of our pre-COVID world.

So, as a reminder to all, as everyone begins to get out more, kids head back to school, life gets busier and everything speeds up – let's not go all the way back to "normal," per our driving habits or patterns. Slow down. Combine trips. Walk or bike if you can. Watch for and give pedestrians and bicyclists the right of way. Let's not let progress fighting the pandemic mean we have to completely lose the calm of quieter streets this past year brought us.

To that end: an invitation to anyone interested in traffic calming and safer streets to attend the spring meeting of the Butterfield Corridor Safe Streets committee. The Butterfield Corridor Safe Streets Committee is a collaboration of neighbors, the Sleepy Hollow Homes Association, all three schools along the corridor, (Brookside, Hidden Valley, San Domenico), law enforcement,

Safe Routes to Schools, the County and Town of San Anselmo. The committee was formed five years by my office, as a way for the community to work together to tackle traffic congestion, safety and education issues throughout the corridor. On Managing Traffic

On February 8th, the Marin County Planning Commission approved amendments to San Domenico's 20-year old Traffic Management Plan (TMP). The changes were requested through a joint application by San Domenico School and SHHA as required by the Schools Master Plan and Use Permit governed by the County. San Domenico is the only school in Marin County whose traffic is regulated by the County.

Over the last several years, SHHA and San Domenico have worked together to develop a proposal for modifying and simplifying the 20-year old TMP that San Domenico has operated under as part of a Master Plan that was approved in 1998. That original Master Plan allowed for the school to increase enrollment from 510 to 680, make campus improvements, and put general parameters around noise, school year and summer-time events, uses, etc. But it also required that San Domenico reduce the number of car trips it generated to 1990 levels, and to keep them there even as enrollment increased to 680. San Domenico achieved this through establish-

ment of school bus program and aggressive traffic management. The 1998 Master Plan approval also allowed for future amendment of the TMP but only through joint application by SHHA and School. This was intended to ensure community engagement and general support for any proposed changes.

The new TMP attempts to simplify a complicated (nearly hour by hour prescriptive) plan. While allowing for a small increase in overall total daily trips which will provide a bit more flexibility during school hours for parent visits, etc., it maintains strict caps on inbound or outbound morning and afternoon commute hour trips. The new plan allows for a small increase in the number of special events, weekend, and summer traffic generation, but the increases are small and traffic count caps remain in place for all events.

Mandatory monitoring on the school's dime will continue at least twice a year in perpetuity. And violations if not cured immediately, will result in fines from \$10,000 to \$50,000 and student enrollment roll-backs if there are successive violations. Any financial penalties will go towards new community safety investments.

No new construction is proposed, and the student enrollment, including onsite resident population, remains unchanged. A comprehensive overview of the process and rationale is available at SHHA & San Domenico Negotiated Agreement and Amendments to Agreement.

SHHA Board Meeting Minutes, February 4, 2021

SHHA Board Meeting Minutes February 4th 2021, 7:00 p.m.
Zoom.

Spencer Adams, President, called the meeting to order. Board members attending: Aya Andrews, David Baker, Jan Blackford, Pete Mayer, Hauyley Mullen, Erik Ruud, Gina Singleton, Matt Testa, Lauren Thornhill. Also attending: Steve McGee, representing the safety concerns of several residents.

Safety: A group of former SHHA Board Presidents and long time Sleepy Hollow Sleepy residents joined the SHHA board meeting to voice their concerns over safety issues facing Sleepy Hollow. Their main concern is the lack of cell service during Public Safety Power Shutoffs and other emergency events. They expressed their interest for the Sleepy Hollow community to accelerate the commencement of construction of the Verizon/San Domenico School cell tower and to improve emergency communication in 2021 before cell service is reliable.

The Board has decided to create a Safety committee, comprised of SHHA Members and SHHA Board members, to look into their questions and concerns and will work closely with the SHFPD on answers. The Board is also looking at other safety concerns and has formed a team to focus on improving awareness of available emergency resources, the potential to have a crosswalk at the Community Center and possibly other locations along Butterfield. We also discussed the possibility of a security camera at the entrance to Sleepy Hollow due to the increase of stolen items from our neighborhood.

Cell Tower Update: Pete Mayer updated the board of the progress of the agreement between San Domenico and Verizon. The two parties are finalizing the agreement for the cell tower and hope to have it finalized soon. Once the agreement is finalized the approve process with County of Marin will start.

Membership: Hayley Mullen updated the Board on the 2021 membership drive. The need to increase membership and increase the value our members receive per their dues. Membership emails have been sent to the community and will continue over the next couple of months. She will be sending letters and forms by mail towards the end of February.

New Logo: The Board approved the use of a new logo for Sleepy Hollow and the different entities, like the SHHA, SHCF and the Community Center. We'll start incorporating the new logo on materials in the next few weeks.

Fundraising: Fundraising for Phase two of the Community Center rebuild will start in late spring/early summer. The Fundraising committee has already started to meet and will continue to plan this important phase of asking for donations for Phase 2, including to renovate the locker/bath rooms, install outdoor showers, and build a new play/fitness area.

Meeting adjourned 9:00 p.m. until March 4, 2021, 7:00 p.m.

MMWD: Drought Emergency for Marin Water

Last Tuesday night the Marin Water Board, unanimously declared a Drought Emergency for Marin Water, which covers most of southern Marin. The goal of that declaration is to immediately send out a public alarm signal, to alert the district's water consuming public of a pending water shortage, and encourage the immediate careful use of all available water.

This is not new for southern Marin. People who have lived in Marin for awhile are aware that our water system is largely dependent on local rainfall each year. We have experienced low rainfall periods and droughts periodically over the years – 1924, 1931, 1939, 1990, 2014, and of course “The Big One” in 1976-77. We have also had near misses – periods of low rainfall up to March and April, and then followed by abundant rainfall in the late system. These events we usually given appropriate names, like the “Miracle of March.”

Even though we are dependent on these events of nature, steps have been taken over the years to prepare for, and mitigate against, the extremes. As a result the district is not in the same position as it was in February 1976 as we approached “The Big One.”

Since then the water district increased the size the capacity of Kent Lake, added Soulajule Reservoir, negotiated long-term contracts with Sonoma Water to import Russian River water, and, as a result of our partnership with Las Gallinas Valley Sanitary District, made recycled water available for irrigation throughout the central portion of our district, with plans prepared to significantly increase that availability.

Accompanying the drought declaration the water district launched a district wide Drought Task Force consisting of staff members throughout the district, all collaboratively working on projects designed to optimize the existing water supply and reduce water demand. The Task Force has prioritized needed repairs, placing at the highest level leak repairs and other repairs which will reduce demand on the water supply.

Phoenix and Soulajule reservoirs are usually used to store reserve water supplies for periods of low water availability. The Drought Task began an early draw down of Phoenix reservoir, and obtained portable generators to facilitate pumping water from Soulajule reservoir into the main stem of the water transmission system. Both of these actions will maximize the supply



from these two sources. In January the water district completed an early purchase of 4,500 acre-feet of water from Sonoma Water, water which is not normally received until later in June.

Among the top priorities of the water district during this water storage will be getting the word out to you - the water consuming public. Our water customers have historically come together on the need for conservation. Historically, when the message goes out that we all need to prioritize how we use our limited water supply the community steps up to that challenge. And, unless we get that “Miracle of March,” now is that time.

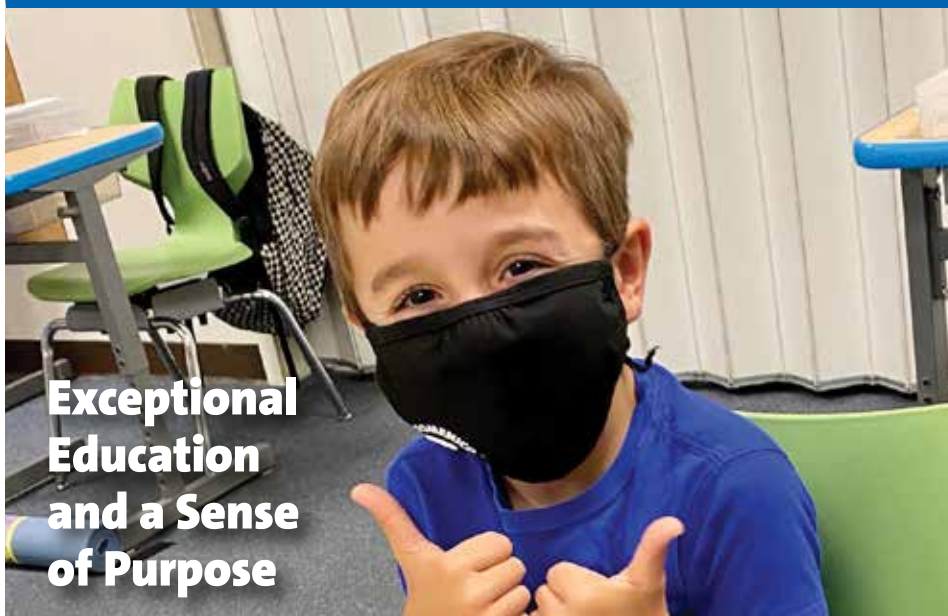

The Home Ignition Problem

FIRESafe MARIN produced a very interesting webinar last month that we encourage all of you to watch.

A recording of the webinar is available on the FIRESafe MARIN youtube channel (https://www.youtube.com/watch?v=ELu_mPm2NTQ&t=1182s) along with recordings of prior webinars and over 75 wildfire safety related videos.

The webinar described inexpensive ways for homeowners to reduce the vulnerability of their home within the first five feet of the structure, the so called Zone 0. It begins with a discussion of what fire professionals call the "Home Ignition Problem." (A page from the webinar is printed below.)

We start with the premise that wildfires are inevitable, thus extreme wildfires are inevitable; but that does not mean that Wildland-Urban fire disasters are inevitable. For many of us the perception of how homes ignite during wildfires is that fire sweeps through the community like a "tsunami" of fire literally exploding houses in flames and leaving destruction in its path. In reality, the typical pattern of destruction is that homes are destroyed but much of the surrounding green vegetation is not consumed. Walls of flame do not sweep through communities destroying everything in their path.

Typically home ignitions result from lofted burning embers and/or low intensity surface fire spreading to contact the structure. Tree canopies typically remain unburned indicating that wildfire flames did not spread through the community and burning trees did not ignite homes. In heavily forested wild lands extreme wildfire behavior does produce canopy fires where trees are completely consumed. In residential areas like Sleepy Hollow the vegetation or local conditions around homes are not sufficient to maintain ignition of intense canopy fires. A roadway can create enough of a fuel break to stop a crown fire but not ember ignition. There are many post fire photos in the presentation that show heavily forested areas where trees are destroyed but across a fuel break large trees are unburned. However, it is common to see homes completely destroyed by embers and surface fires while the tree canopy is untouched. The answer is to make homes ignition resistant during extreme wildfire.

One of the first things we all should do is to prevent burning within 5 feet of flammable building materials. That means creating a non-ignition zone within 5 feet of a home and its flammable attachments. To the right, are some simple, practical options to protect your home from wildfire embers.

1. Make sure there is a vertical separation of at least 6 inches between the ground and combustible siding.
2. Use only noncombustible mulches such as gravel, decomposed granite, or compost. Avoid bark, especially "Gorilla Hair."
3. Install noncombustible fences and gates. This is particularly important in areas where they make contact with the home.
4. Decks and porches should be screened to prevent ember entry and there should be no combustible materials stored under decks.
5. Remove leaf litter frequently within the first five feet. Don't just move it to another location, strong winds during fires will blow it back against the home.
6. Move combustible outdoor items indoors or 30 feet from structures. This includes patio furniture cushions, wicker furniture, toys, natural fiber doormats, plastic trash cans, firewood and lumber.
7. Make fire smart landscaping choices. The next two FIRESafe MARIN webinars will discuss in greater detail.

2021 Membership – “What your dues do”

Our 2021 membership drive for the Sleepy Hollow Homes Association (SHHA) and Community Pool is open! New members can join, and existing members can renew, at www.shha.org.

Your dues are vital to SHHA and, among other things, support the operations and maintenance of the Community Center and Pool, and various SHHA-arranged social activities, including our cherished 4th of July in the Hollow, as well as communication and advocacy efforts on behalf of Sleepy Hollow, all of which help sustain and build our community. SHHA is working to improve cellular connectivity in the community, which has been top of mind for many of us in light of our recent experience with the power shut-offs and wild-fire risk. In addition we have a lot more community center offerings in the works that will enrich our community events even further!

All of these awesome offerings happen only with our community’s continued support through your SHHA membership dues.

POOL OPENING: SHHA currently anticipates opening the pool Memorial Day weekend through Labor day weekend, and weekdays when school is out for summer. The pool, locker room and snack bar will be open in compliance with COVID-19 requirements at the time. For example, we may need to start out with registered swim times and ease the process as quickly as conditions permit. We will expand lap swim options early, throughout the season, and late if we can. SHHA members may join at any time. Friends of Sleepy Hollow registrations will begin soon.

SHHA annual dues are \$310 (\$280 for seniors 65+). Residents can add a Commu-

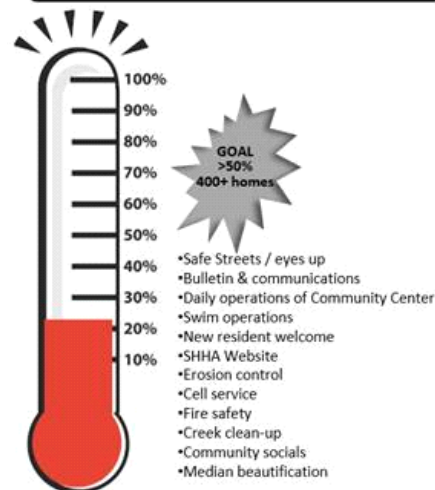
nity Pool membership for just \$250 (\$200 for seniors). When you renew or join on the website, you can also choose an annually recurring SHHA membership: your credit card will be automatically charged annually and you will also receive \$10 off your SHHA Membership. If you previously elected automatic renewal there is nothing for you to do; your renewal will be processed on March 15th. All residents will receive a postal mailing with information and paper forms you can use to join or renew and pay by check.

Progress in vaccinating oldest residents makes room for next group

Having vaccinated more than 60% of all Marin County residents above age 65, Marin County is moving to provide COVID-19 vaccine to educators, food service workers, and other essential workers, following the regulations laid out in the California state vaccination plan. Starting February 24, all residents who fall into Tier 1 of the current phase of the state plan are eligible to schedule appointments for vaccinations:

education, food service, child care, agricultural, emergency services. Vaccinating this group will offer our community another crucial layer of protection as vaccine rolls out.

While workers in the five sectors are now eligible to receive a vaccine anywhere in the Bay Area, vaccine appointments remain in limited supply. Vaccine providers remain challenged by limited allocations from state and federal sources.

Measures are being taken to reserve doses for those at highest risk, and some health care providers may continue to prioritize vaccine for patients who are 65 and older and have not yet had an opportunity to be vaccinated. A list of Marin-based vaccine providers, including eligibility and appointment information, is listed on Public Health’s vaccine options webpage.

Stay informed of progress by subscribing to Public Health’s daily status updates. The emails contain information on vaccine progress, announcements of when new vaccination phases open, and other relevant COVID-19 information.
